# Introduction

#### Why a Framework for Action?

This Framework for Action is a tool for guiding social investment and actions in the 10 priority areas of intervention of the National CSR Foundation. It aims at providing strategic directions for:

- More impactful services, programmes and projects to the benefit of the poor and vulnerable groups
- Advancing national social development policy objectives and Sustainable Development Goals (SDGs).

#### What is in the Framework?

The Framework for Action defines 4 dimensions of social inclusion, equity and sustainable development. It aligns national policy objectives, human rights instruments and SDGs and identifies related programmes in the 10 priority areas of intervention of the National CSR Foundation.

#### Who is it for?

This Framework is intended for broad use by non-governmental/non-profit organisations (NGOs/NPOs) and other stakeholders seeking to contribute to the 4 dimensions of social inclusion, equity and sustainable development through relevant actions targeting the poor and vulnerable groups.
